Examples: From the book *Study Guide* (2000) ... or ("Reading," 1999). Note: Titles of periodicals, books, brochures, or reports should be in italics and use normal title capitalization rules.

Formatting Book Citations. Citations of books in your Reference List should begin with the last name of the book's author, then the author's initials.

Is a Book Title Underlined or Italicized When Typing in ...

Basic book citation format. The APA in-text citation for a book includes the author's last name, the year, and (if relevant) a page number. In the reference list, start with the author's last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns).

How to Cite a Book in APA Style | Formats & Examples

APA Style uses two kinds of capitalization to format reference titles, which are also mentioned in the table above: title case and sentence case. APA's title case refers to a capitalization style in which most words are capitalized, and sentence case

APA Book Citation | APA Format

An APA in-text citation includes only three items: the last name (s) of the author (s), the year the source was published, and sometimes the page or location of the information. References include more information such as the name of the author (s), the year the source was published, the full title of the source, and the URL or page range.

Citing a Book in APA | Citation Machine

APA recommends that your title be focused and succinct and that it should not contain abbreviations or words that serve no purpose. Your title may take up one or two lines. All text on the title page, and throughout your paper, should be double-spaced. Beneath the title, type the author's name : first name, middle initial(s), and last name.

How to Cite a Book (Title, not chapter) in APA Format Book referencing is the most basic style; it matches the template above, minus the URL section. So the basic format of a book reference is as follows:

According to APA format, italicize the book title (here "Being in Love"). Write the name of the author in parentheses, along with the year a work was published and the page number you are referencing. Place this at the end of your sentence, before the period.

APA Style uses two types of capitalization for titles of works (such as paper titles) and headings within works: title case and sentence case. In title case, major words are capitalized, and

Title of the article or work "Lifestyle Disease and Mortality"*For works with short titles, write the full title in the in-text citation, whereas for long titles, include only the first few words enclosed in double quotation marks.

The American Psychological Association (APA) has specific guidelines on how to include an article title in the text of your writing. Consider section 4.21 of the APA Publication Manual "Use of Italics;" according to it, italics should be used for titles of books, periodicals, films, videos, television shows, and microfilm.

The 7th edition of APA does not differentiate between the format of the books, print or electronic. Cite both the same way. If you have an open-access eBook, you may provide the URL at the end, provided it directly takes you to the full text without logging in.

Place one double-spaced blank line between the paper title and the author names. Center author names on their own line. If there are two authors, use the word "and" between authors; if

there are three or more authors, place a comma between author names and use the word “and” before the final author name.
