Lord Manning: it is about fulfilling the reasonable expectations of honest men. There is almost an obsession for commercial certainty- with a series of predictable rules that often lead to unfairness. The law should not concern itself with distributive justice or the regulation of faith. It should simply enforce the agreement of the parties.
